Utility Scam Awareness

We want to warn our members to be on guard for scams targeting payment on their electric bill. Here are some things to look for in a potential scam call:

- » Caller will contact you and inform you that your power will be disconnected in a short period of time if you do not make an immediate payment on your account.
- » Caller will ask for payment with a prepaid credit card or gift card.
- » Caller will ask for personal and financial information.

Know that REA will never call and demand quick payment over

the phone while threatening disconnection with no prior communication. REA members who are delinquent will receive a disconnect notice by mail and REA will attempt phone calls (if we have correct phone numbers) prior to disconnection. Contact REA if you receive a questionable call.

October is National Cooperative Month, and I find it fitting that we would also celebrate Operation Round Up. When I reflect on the cooperative way of doing business, the Operation

Round Up program is a unique community service that sets us apart from other utilities.

After seeing Operation Round Up come to life in electric cooperatives across the country, REA Management brought an advisory vote to the attendees of the REA Annual Meeting in 2002. With overwhelming approval, the program was launched by the end of that year, and grants were awarded for the first time in early 2003. Since that time, over 2,400 grants have been awarded, totaling over \$1.2 million!

We want to express our heartfelt gratitude to the thirty REA members who have served on the REA Operation Round Up Community Trust Board since 2002. Representing each of REA's seven districts, the board

REA Board of Director Meeting Highlights - August 2024

- » Reviewed the Financial Report for July 2024. Sales remain behind budget 10.5% and down 9.5% from last year through July.
- » REA Purchasing Agent Derick Swenson reviewed 2023-2025 large equipment purchases and projected delivery dates.
- » STAR Energy Service CEO Lois Croonquist provided an update on the organization's structure, employee recruitment and retention, building density within geographic footprints, locations for growth, and opportunities for new products and services.
- » Approved a senior capital credit retirement request in excess of \$10,000 per REA Policy C12 - Capital Credits.
- » CEO Haman reviewed the presentation of the director's compensation resolution to the Member Advisory Council at the August 1st Council meeting. No action was taken. The Council will vote on the compensation resolution in November.
- » The regular October Board Meeting will be Tuesday, October 29, 2024 at 9:00 a.m.

Operation Round Up Distributes \$11,814 in September!

Through the contributions of Runestone Electric Association's participating members, the Operation Round Up® Trust Board recently approved \$11,814 to assist local community programs during its quarterly meeting.

REA's Operation Round Up Trust Board, a voluntary board of seven REA members, reviewed and considered 24 grant applications and distributed funds to 22 projects and programs this past quarter. Community-based projects and programs have received over \$1.2 million since the program's inception in 2003. On average, participating REA members contribute \$6.20 for the year. Proof that small change adds up. Best of all, 95% of all funds collected are distributed as grants.

If you have a dual fuel heating system, also known as an off-peak system, now is the time to be sure your off-peak controls are functioning and your back-up system is prepared. Your fuel supply should be checked and chimneys cleaned.

Summer storms can damage equipment controls within off-peak heating systems. It is the member's responsibility to contact an electrical contractor should the system not be functioning correctly.

If you have electric heat, but are not sure if you are on the dual fuel program, please call REA at (800) 473-1722.

Dual Fuel Participants Tips & Reminders:

During the heating season, the electric heat portion of your dual fuel system may be controlled up to a maximum of 400 hours, however this is rare.

- » Control will not exceed 12 hours per control event.
- » If you're on dual fuel, check the electric and non-electric (dual) parts of your heating equipment now.
- » Fill your fuel tank full in case it needs to run for hours at a time.
- » We anticipate more control in the morning.
- » Check on the likelihood of control by visiting www.RunestoneElectric. com and select "Today's Load Control"
- » Sign up to get text messages on control days text #loadcontrol to 22300.



Plans to escape the cold this winter?

Stop and read BEFORE turning off your water heater at your electrical panel

Turning off your water heater when leaving on extended trips can be a good idea as long as you follow these tips:

1. Check your breakers

Don't turn off the breaker if you have a yellow sticker (pictured) or if your electrical panel lists your water heater circuit powering your off-peak meter and controller. If the breaker is turned off, you will miss out on the value of off-peak rates while you're away.

2. Disconnect Switch

Have your electrician install a disconnect switch. Installed next to the water heater, a disconnect switch lets you shut off your water heater while maintaining power to the off-peak meter and controller.
